Annual Business Meeting

New England Vegetable & Fruit Conference, Manchester, NH December 16, 2009

The Annual Business Meeting was called to order at 12:10 PM by President André Tougas. President Tougas offered words of welcome to the membership. Twenty-five individuals were present.

Secretary's Report

One hundred and twenty-one individuals paid membership dues for 2009. An additional 27 had previously committed to the 10-year-membership/matching program with the Massachusetts Society for Promoting Agriculture and the Commonwealth. Their active membership will continue through 2015. Below are the membership figures for 2000-2009.

The 2009 Annual Business Meeting was on January 15, 2009 at the UMass Cold Spring Orchard in Belchertown, and the Annual Summer Meeting was on July 15 at Tougas Family Farm in Northborough, with more than 100 people in attendance. The Board of Directors met on February 20 and November 13, 2009. The Secretary's Report was moved, seconded, and passed unanimously.

Minutes of the previous (January 15, 2009) Annual Business Meeting were presented, moved, seconded, and passed unanimously.

Treasurer's Report

The General Fund began the year with a balance of \$53,174.22. Receipts totaled \$76,844.46, and disbursements totaled \$104,220.08. The balance on December 31, 2009 was \$25,798.60. The Horticultural Research Fund began the year with a balance of \$285,774.17. A total of \$8.46 in receipts and \$4,400.00 expenses occurred in 2009. The balance in the Horticultural Research Fund on December 31, 2009 was \$330,451.02. In 2009, the Horticultural Research Fund gained 15.2% in value (including income and expenses). The overall investment increase was 16.8%. The Treasurer's Report was moved, seconded and passed. Details follow on the next page.

Other Business

Cleve Willis discussed the Prokopy Memorial Endowment which will support a position at the University of Massachusetts in tree-fruit entomology. Several individuals are members of the memorial committee.

Legislative (Dowse), Harvest Labor (Davis), Marketing (Nicewicz), and Research & Grants (Tougas) Committees and the Trustees of the UMass Horticultural Research Center (Davis) reported.
