# **Annual Business Meeting**

## Massachusetts Fruit Growers' Association, Inc.

New England Vegetable & Fruit Conference, Manchester, NH December 14, 2011

The Annual Business Meeting was called to order at 12:30 PM by Vice President Andrew Martin. Vice President Parlee offered words of welcome to the membership. Forty individuals were present.

#### Secretary's Report

One hundred and one individuals paid membership dues in 2011. An additional 27 had previously committed to the 10-year-membership/matching program with the Massachusetts Society for Promoting Agriculture and the Commonwealth. Their active membership will continue through 2015. Below are the membership figures for 2004-11.

The 2011 Annual Business Meeting was on January 7, 2011, at the Commonwealth Quality Certification Meeting in Sturbridge, MA, and the Annual Summer Meeting was on July 18 at Parlee Farms in Tyngsborough, with approximately 80 people in attendance. The Board of Directors met on March 15 and November 16, 2011.

Minutes of the previous (January 7, 2011) Annual Business Meeting were presented, moved, seconded, and passed unanimously.

#### Treasurer's Report

The General Fund began the year with a balance of \$40,558.02. Receipts totaled \$18,581.08, and disbursements totaled \$23,449.87. The balance on December 5, 2010 was \$35,689.23. The Horticultural Research Fund began the year with a balance of \$295,502.13. A total of \$322.66 in receipts and \$6,459.42 in expenses occurred in 2011. The balance in the Horticultural Research Fund on November 30, 2011 was \$292,280.50. In 2011, the Horticultural Research Fund lost 1.1% in value (including income and expenses). The overall investment increase, however, was 1.0%. The Treasurer's Report was moved, seconded and passed. Details follow on the next two pages.

Ken Nicewicz, the Auditor, reported that the Treasurer's Report was complete and accurate as presented. The Auditor's Report was moved, seconded, and passed unanimously.

#### **Other Business**

The Marketing and Harvest Labor Committees and Trustees of the Horticultural Research Center presented brief reports. Rick Lablanc from MDAR reported on a program to place advertising in commuter trains promoting retail agriculture. The membership generally supported this effort, and the Directors will discuss a contribution on behalf of apple sales at their February meeting.

Ken Nicewicz reported on current progress with the development of and endowment to support a position at UMass (Ronald J. Prokopy Extension Assistant Professor of Fruit Insect Pest Management). He reported that prospect were good for a few significant contributions and additional efforts are underway to secure those prospects and to evaluate others. It was moved that the Endowment Committee continue working on this

project with the possibility of coming to the Association or the membership for additional funds. The motion was seconded and passed unanimously.

## **Nominations Committee Report and Elections**

On behalf of the Nominations Committee, Autio presented a slate of candidates for officers and directors, including Andrew Martin for President, Al Rose, Glenn Cook, and Joann Dinardo for Vice Presidents, Wes Autio for Secretary and Treasurer, Ken Nicewicz for Auditor, and Frank Carlson, David Chandler, Larry Doe, Brad Morse, Andre Tougas, and Mo Tougas for Directors. No additional nominations were received from the floor. Nominated candidates for president, vice president, secretary, treasurer, and auditor were elected. Frank Carlson, David Chandler, Andre Tougas, and Mo Tougas were elected as directors for 3 years.

The meeting was adjourned at 1:15 PM.
