# Minutes Annual Business Meeting Massachusetts Fruit Growers' Association, Inc.

Via ZOOM January 13, 2021

The Annual Business Meeting was called to order at 10:00 AM by President Ben Clark. President Clark offered words of welcome to the membership. Eighty-one individuals were present.

## Minutes of the December 11, 2019 Annual Business Meeting

The minutes of the previous Annual Business Meeting (December 11, 2019) were reviewed. A motion was made, seconded, and passed unanimously to approve the minutes as presented.

## Secretary's Report

After two membership renewal mailings, 123 individuals paid 2020 membership dues. Below are the membership figures for 2014-20.

The Annual Business Meeting was on December 11, 2019, at the New England Vegetable & Fruit Conference in Manchester, NH, with about 30 members in attendance. The Directors met via Zoom on March 18 and December 3, 2020.

## Treasurer's Report

The General Fund began the year with a balance of \$80,063.71. Receipts totaled \$21,053.68, and disbursements totaled \$17,436.51. The balance on December 31, 2020 was \$83,680.88. The Horticultural Research Fund began the year with a balance of \$224,297.00. A donation for \$48.51 was received, and a total of \$1,178.64 was disbursed in 2020. The balance in the Horticultural Research Fund on December 31, 2020 was \$245,658.16. The Treasurer's Report was moved, seconded and passed. Details follow on the next page.

The auditor (Nicewicz) stated that he reviewed the financial material and found them in good order. The Auditor's Report was moved, seconded and passed unanimously.

## **Other Business**

Legislative (Dowse), UMass Fruit Advisory (Carlson), Harvest Labor (O'Toole), and Marketing (Nicewicz) committees and the Trustees of the UMass Cold Spring Orchard (Carlson) gave very brief reports.

Motion (Tougas): MFGA will contribute \$1000 to the International Fruit Tree Association Research Fund. The motion was seconded and passed unanimously.

#### Nominations Committee Report and Elections

On behalf of the Directors, Autio presented a slate of candidates for officers and directors, including Ben Clark for President, Mark Tuttle, Joel O'Toole for Vice Presidents, Wes Autio for Secretary and Treasurer, Ken Nicewicz for Auditor, and Frank Carlson, Peter Mitchell, Al Rose, and André Tougas for Directors. No additional nominations were received from the floor. Dowse moved that the nominations be accepted and that the secretary be directed to cast a single vote for the entire slate. The motion was seconded and passed unanimously.

The meeting adjourned at 10:42 AM.
