Secretary's Report

Treasurer's Report

The General Fund began the year with a balance of \$85,791.19. Receipts as of March 11 totaled \$21,546.12, and disbursements totaled \$4,822.28, leaving a balance of \$102,515.03. The Horticultural Research Fund began the year with a balance of \$293,085.13. The balance in the Horticultural Research Fund on March 10 was \$272,783.95, for a change of -6.9% so far this year. The Treasurer's Report was moved, seconded, and passed unanimously.
