Secretary's Report

Treasurer's Report

The General Fund began the year with a balance of \$105,610.64. Receipts as of March 18 totaled \$12,749.03, and disbursements totaled \$4,897.86, leaving a balance of \$113,461.81. The Horticultural Research Fund began the year with a balance of \$301,531.84. The balance in the Horticultural Research Fund on March 18 was \$328,822.74, for a change of +9.1% so far this year. The Treasurer's Report was moved, seconded, and passed unanimously.
